### BCARES ACTIVITY

It really started a few months ago. More requests for assistance in providing communications for various events began arriving faster than we could react to them. Some we were able to help, but a few we had to refer to others, simply because the lead time was too short, or we weren't able to come up with enough people for the task.

I wish we could just say the word and have all the personnel needed volunteer. However, I realize that most of have our own obligations and most of those involve family. Those obligations must come first.

Our group (BC-ARES) is not huge by any standard, but we do have a dedicated core group that can handle almost anything. Sometimes we have to come to a larger audience and ask for help, and we will when necessary.

Our most recent project is a WNC Weather Net, being put together by Dwight Danner, W4DCD and Paul Tilley, KK4BRD. Eventually, they hope to have people all over western North Carolina involved in the "net" with the express purpose of providing real-time weather related information to the National Weather Service (NWS) at the Greenville Spartanburg office.

A meeting on July 18<sup>th</sup> will include the beginning of a training process to familiarize volunteers with the necessary information the NWS needs from this area, and we propose to get that information to them. At the Hamfest on July 27<sup>th</sup> we will have an ARRL/ARES meeting. At this meeting we expect to have folks from all over WNC and we will solicit help from those particularly from the western counties of the state to help with this project.

Dwight has asked for volunteers to act as "observers" as well as potential Net Control stations for this project. We will follow-up on that in the coming weeks.

A previous project is about to become a reality, the Mission Hospital Winlink project. We will be getting an update on this at our July 18<sup>th</sup> meeting from personnel from the Hospital.

I want to thank all those who have come forward to help if/when asked. Our ability to respond to these requests for communications assistance can only add to the reputation amateur radio has achieved – that of being able to DO IT when needed.

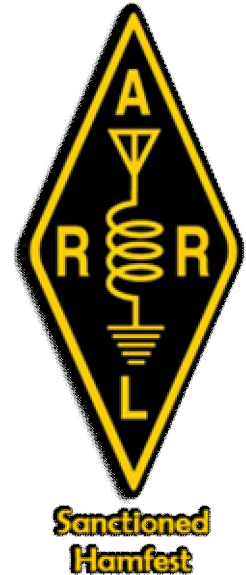

## Phishing Scam via ARRL.net E-mail Addresses Reported

Several ARRL members have reported that someone posing as "Arrl.net Online Services" is prompting members to provide personal information. These e-mails ask the user for his or her username and password.

These e-mails do not come from the ARRL. The League would never ask you for this sort of information in this fashion. The best course of action is to ignore such requests and, as a general precaution, never send personal information via e-mail.

## Emergency Radio: Colorado ARES Supported Emergency Communication in Wildland Fire Response

Colorado Amateur Radio Emergency Service (ARES) volunteers mustered to support emergency communications after wildland fires broke out in June.

"For the second summer in a row the entire state of Colorado seems to be on fire," said North Central Colorado Region ARES Emergency Coordinator Perry Lundquist, W6AUN. "Currently there are 16 wildfires burning within Colorado."

Several Colorado ARES districts activated in the wake of the Royal Gorge and Black Forest fires June 11. Members provided communication support for sheltering activities. Later the same day, the Black Forest Fire erupted close to the Waldo Canyon area in Colorado Springs



where a similar wildfire caused widespread destruction last year. "The Black Forest Fire has now become the most destructive fire in Colorado history," Lundquist said. It ultimately consumed 14,280 acres and 507 homes and caused two deaths.

During the fire's peak, eight shelters were opened for both people as well as animals large and small, Lundquist reports. More than 35,000 residents had to evacuate, he said, which placed a very heavy burden on the American Red Cross, which immediately requested ARES communication support between its eight various shelters and the Pikes Peak Red Cross headquarters. ARES volunteers responded by providing around-the-clock radio operators for several days.

Lundquist said in late June that several Jefferson County ARES members were still working on other fires within the state where their ARES members are assigned individually as National Wildfire Coordinating Group (NWCG) certified communication technicians and radio operators. "Colorado Section and Regional ARES leadership has worked closely to support the local ARES districts and to provide ARES mutual aid in the form of communications equipment and ARES-trained manpower resources wherever and whenever needed," he said. -- Thanks to Perry Lundquist, W6AUN; Colorado SM Jack Ciaccia, WMØG, and Rick Palm, K1CE

### **ARRL Urges Denial of Petition to Permit Encryption of Some Emergency Communications**

The ARRL is calling on the FCC to deny a Petition for Rule Making (RM-11699) seeking to permit the encryption of certain amateur communications during emergency operations or related training exercises. Don Rolph, AB1PH, of E Walpole, Massachusetts, petitioned the Commission in March to suggest an additional exception to §97.113, which currently prohibits

encoded for the purpose of obscuring their meaning."

"While Mr Rolph has concisely stated his argument, it is ARRL's considered view that there is no factual or legal basis for the assumption that encryption of transmissions...is necessary in order to continue and enhance the utility of Amateur Radio emergency and disaster relief communications," the League said in its comments, filed today with the FCC. The ARRL also turned away Rolph's assertion that the current prohibition in §97.113 "has impacted the relationship of Amateur Radio volunteers and served agencies and significantly limited the effectiveness of amateurs in supporting emergency communications." The League said it's unaware of any evidence that served agencies have been reluctant to utilize Amateur Radio as part of their emergency or disaster relief communications plans because of the encryption restrictions in Part 97. The Amateur Service rule is based on a similar prohibition in international telecommunication law, the ARRL noted.

The League characterized as "erroneous" and "unfounded" Rolph's assumption that encryption of certain information may be required under the provisions of HIPAA — the Health Insurance Portability and Accountability Act. "This mistaken assumption leads to the conclusion that the inability of Amateur Radio operators to encrypt the content of their transmissions in order to obscure the meaning of the transmissions renders Amateur Radio less (and decreasingly) useful to served agencies than it would be if encryption of those transmissions was permitted," the ARRL said. The League also said it was unaware of any instance in which state statutes have been cited by any served agency or group as a reason not to employ Amateur Radio for emergency communication.

Radio amateurs, the ARRL countered, are not “covered entities” under HIPAA, which applies only to health care providers, health plans and health care clearinghouses. And, the League added, there is no expectation of privacy in Amateur Radio communications.

The ARRL said it’s not possible to determine the validity of the claim “that health care agencies subject to HIPAA are or might be unwilling or reluctant to utilize Amateur Radio in emergency communications and disaster relief planning” because of any lack of privacy inherent in Amateur Radio. “Permitting encryption might remedy the concern as a practical matter, if the concern exists,” the League continued, but “the complete dearth of even anecdotal evidence of the existence of that concern” makes it impossible to justify the proposed rule change on that basis.

“It is extremely important to insure that Amateur Radio remains useful to served disaster relief and emergency communications agencies, which include health care facilities,” the League stressed. “It is just as important to insure that regulatory impediments to that volunteer work be minimized to the extent consistent with the nature of the Amateur Radio Service.” Amateur Radio’s utility to served agencies in supporting emergency communication, the ARRL continued, “is high indeed, and is at the present time unfettered by the inability to encrypt transmissions.”

However, the ARRL said that should it become necessary in the future for radio amateurs to protect the privacy of individuals whose medical data may be transmitted by Amateur Radio during or after an emergency or disaster, “the Commission may be asked to revisit this matter.”

“It is urgent that Amateur Radio continue to be an essential component of disaster and emergency communications planning,” and that served agencies, including medical facilities, perceive the utility of Amateur Radio as unhindered by regulations that prohibit encryption, the League emphasized.

More than 200 comments were filed on RM-11699, most of them tending to support the ARRL’s arguments.
